Under this plan, fees are converted quarterly into phantom shares at the fair market value of the company's Class A Common shares on the last trading day of each quarter. Upon retirement as a director, the balance may be paid in either shares or cash. The balance at 3/31/04 is 9,238.14 phantom shares.

2. The exercise price of this nonqualified stock option award granted under the company's Long Term Incentive Plan is \$105.82.
